Brief about Event

SU Start-up and Entrepreneurship Council, in collaboration with IIC Saurashtra University, organized a seminar on "World Entrepreneurs Day" on 21st August 2023. The event was held at Seminar Hall, Department of Statistic, Saurashtra University. Session started with lamp lighting and prayer.

Ms. Khilna gave information to students that every year on August 21st, the global community comes together to celebrate World Entrepreneurs Day. This special day recognizes and honours the contributions of entrepreneurs and business leaders worldwide. It served as a platform to celebrate their innovation, dedication, and the vital role they play in shaping our economies and societies. As we celebrate this day each year, we are not only honouring the achievements of renowned entrepreneurs but also encouraging aspiring ones to embark on their entrepreneurial journey, fostering economic growth, and building a brighter future for all. Entrepreneurs truly are the architects of progress, shaping the world one idea at a time.

This are the main three importance of World Entrepreneurs Day honouring visionaries and innovators, knowledge sharing, economic contribution etc. The role of entrepreneurs in the economy is to job creation, innovation and technological advancement, community development, global impact, international trade, wealth creation, innovation and technological advancement, disruption and market expansion.


Madam told about investor Facilitation Portal is a single window online platform which acts as the first point of contact for any probable investor in the State of Gujarat. It also facilitates for online filling of all required forms, online payments, downloading online certificates, licenses and a grievance redressal mechanism an investor doesn't need to approach any department for taking any approvals. All the processes can be completed online via www.ifp.gujarat.gov.in (single window portal) as suggested in the Single window user guide on home page. Students can register and start with prior to availing any of the services, an investor may first register with Investor Facilitation Portal. An investor will get login id and password. Further, an investor may login and apply for necessary approvals required for setting up of the business. investor Facilitation Portal is integrated with government department systems and online portal. An investor can check the current status of the application via Investor Facilitation Portal at the application dashboard. The user will also get an email or SMS upon any change of the status of his application

In 'One Stop Information' tab the information on suitable land parcels is available. The investor can find details on Gujarat Industrial Development Corporation (GIDC) estates, private industrial estates, SIRs and SEZs etc. An investor may have multiple units under single name and can apply for approvals required to operate multiple units through a single user id by registering new units under the same user id. The same PAN number should be used for the login. The grievances can be lodged once the investor registered itself in IFP. The grievance would be redressed within 10 working days.

After that student learned about the Udyam Registration. Government has organised a full system of facilitation for Registration Process. An enterprise for the purpose of this process will be known as Udyam and its Registration process will be known as 'Udyam Registration'. A permanent registration number will be given after registration. After completion of the process of registration, a certificate will be issued online. This certificate will have a dynamic QR Code from which the web page on our portal and details about the enterprise can be accessed. There will be no need for renewal of registration. Our

single window systems at champions control rooms and at DICs will help you in the process. registration process is totally free. No costs or fees are to be paid to anyone. Any person who intends to establish a micro, small or medium enterprise may file Udyam Registration online in the Udyam Registration portal, based on self-declaration with no requirement to upload documents, papers, certificates or proof. On registration, an enterprise (referred to as "Udyam" in the Udyam Registration portal) will be assigned a permanent identity number to be known as "Udyam Registration Number". An e-certificate, namely, "Udyam Registration Certificate" shall be issued on completion of the registration process.

Then Madam talked about Registration Under MSME Intent Act and share the process:



Afterwards students understand MSMEC Incentive Schemes. There is main three schemes

 - Scheme for Assistance to Micro, Small and Medium Enterprises (MSME)

 - Scheme of Assistance to GIDC for development of Multi Storeyed Sheds for Micro and Small Enterprises (MSEs)
 - Micro And Small Enterprise Cluster Development Programme
 - Funding Facilities and many more schemes.

 - Industrial Undertaking
 - Micro, Small and Medium Industrial undertaking
 - Large Industrial undertaking
 - Mega Industrial undertaking
 - Ultra Mega Industrial undertaking

- 3. Aatmanirbhar Gujarat Schemes 2022
 - Assistance for Capital Investment Subsidy to micro, Assistance for Interest Subsidy and Assistance for Reimbursement of CGTMSE Fees
 - Net SGST Reimbursement to Micro, Small and Medium manufacturing Enterprise
 - Assistance for Quality Certificate
 - Assistance for Enterprise Resource Planning (ERP)
 - Financial Support to MSMEs in ZED Certification and many more schemes

Outcome

Ms. Khilna Mehta informed students about World Entrepreneurs Day, celebrated on August 21st each year. Madam also talked about the Investor Facilitation Portal (IFP) in Gujarat, a one-stop online platform for investors. Students learned about Udyam Registration, a government system for registering micro, small, and medium enterprises (MSMEs).

Then discussed the process for Registration Under MSME Intent Act, which includes applicant details, enterprise address, contact information, enterprise info, activity location, and a declaration. Afterwards students were introduced to MSMEC Incentive Schemes, including schemes under Industrial Policy 2020, Industrial Policy 2015, and Aatmanirbhar Gujarat Schemes 2022, aimed at supporting MSMEs through various subsidies, reimbursements, and assistance programs.
